Sub.: Extension of Approval for imparting B.Arch./ M.Arch. degree and Diploma courses for the academic session 2024-2025— Extension of last date for submission of Online Application - reg.

Dear Sir/Madam,

As you are aware, the Council of Architecture, a Statutory Body of the Government of India, regulates the Architectural Education throughout the country under the provisions of the Architects Act, 1972. The Council has recently opened its web-portal <a href="https://ecoa.in/academic/public/">https://ecoa.in/academic/public/</a> to enable approved Institutions to apply for extension of approval for architectural course(s) for the academic session 2024-2025 by filling up Online Application(s). As per the previous revised academic calendar prescribed by the Council, the last date for submission of applications by institutions was upto February 5, 2024.

Due to many requests received from various institutions, the competent authority of the Council has decided to extend the last date for submission of applications for extension of approval for architectural courses(s) till **February 12, 2024**. The last date for submission of applications with penalty shall be upto **February 26, 2024**. The revision in dates shall also be applicable for Diploma courses as well as for applying for enrolment number of students at the COA Portal. The revised academic calendar is attached herewith and also updated at the website of the Council.

In view of the above, all institutions approved by the Council for imparting B.Arch./M.Arch./Diploma course in the country, are requested to apply for extension of approval within the said last dates for the ensuing session 2024-2025.

- **Note**: 1. Applications for introduction of UG course (B.Arch.) and additional intake shall be accepted by the Council only for a maximum intake of 40 and shall be processed in terms of the Perspective Plan for growth of Architectural Education prescribed by the Council (available at COA website).
  - 2. No new institution will be permitted in regions falling under Category-IV of Perspective Plan of COA for introduction of B.Arch. course.
  - 3. Applications for additional intake shall be accepted only from institutions which have been imparting B.Arch. course for a minimum period of 3 years (i.e. at least 3 batches at the institution) and processed as per Perspective Plan of COA.
  - 4. Any institution which has applied for introduction of B.Arch. course for academic session 2024-2025, may withdraw its application prior to inspection with charges of Rs.50,000/-.
  - 5. Institutions which are not due for extension of approval for 2024-2025 are required to fill up Application for mandatory disclosure with charges of Rs.25,000/- per programme.

6. The Classes for B.Arch. shall commence latest by September 1, 2024.
