Subject: Violations of the Architects Act, 1972 by CPWD by directing its officers not to follow the conditions of engagement and scale of charges prescribed by the Council.

Respected Sir,

We would like to be eech your goodself to kindly intervene and save the profession of architecture from being ruined at the hands of officers of CPWD, Govt. of India.

The CPWD has recently issued Office Memorandum/ Circular NO.DG/P&WA/79 dated 16/12/2015 advising Officers of CPWD not to use conditions of engagement and scale of charges prescribed by the Council of Architecture under its Regulations for granting work to consultant architects for providing Architectural Services. A copy of the circular is enclosed herewith.

Sir, as you are aware that Architects Act, 1972, was enacted by the Parliament of India keeping in view the fact that since Independence and more particularly with the implementation of five-year plans, the building construction activity in our country had expanded almost on a phenomenal scale. A large variety of buildings, many of extreme complexity and magnitude, like multi-storeyed office buildings, factory buildings, residential houses were being constructed each year. With this increase in building activity, many unqualified persons calling themselves as architects were undertaking the construction of buildings which were uneconomical and quite frequently were unsafe. In order to protect the general public from unqualified persons working as Architects, the Parliament decided to pass the legislation making it unlawful for any person to designate himself as "architect" unless he has the requisite qualifications and experience and is registered under the Act.

The Council as empowered under Sections 22, 30 and 45 of the Act laid down Architects (Professional Conduct) Regulations, 1989 and also laid down Conditions of Engagement and Scale of Charges for Architects and Architectural Competition Guidelines for Appointment of Architects.

Sir, after having followed the Council's norms for more than 40 years the CPWD has now issued an unreasonable, illegal, arbitrary and unconstitutional Circular that the Conditions of Engagement and Scale of Charges prescribed by the Council be not followed and thus putting all architects in breach of Professional Conduct Regulations prescribed under the Act.

While on one hand CPWD itself is charging 3 to 5% fees (as per CPWD Works Manual) for providing Architectural Consultancy Services to Govt. Departments for construction of their Buildings on the other hand it is sub-contracting the works to practising architects by seeking lowest quotations from them. This is clearly an unfair, unhealthy and monopolistic practice by a government department and discrimination with practising Architects.

We humbly request your goodself to direct CPWD to withdraw this circular immediately to restore the faith of the citizens, especially architects in the law of the land i.e. Architects Act, 1972 and our professional brothers who are at helms of affairs in CPWD do not put Architects to exploitation and unhealthy professional environment and unreasonable and unfair competition.

Looking forward to an urgent positive action in the matter in public interest.

- 2. The conditions of engagement and scale of charges prescribed by the Council of Architecture are neither approved by the Parliament under the Architects Act, 1972 nor by the Central Government.
- 3. All CPWD officers are advised that the conditions of engagement and scale of charges prescribed by the Council of Architecture shall neither be used for granting work to any consultant architect for his services nor shall be used as a justification for the quote received from any architect. The same is against the interest of Government.

This supersedes circular no DG/P&WA/76 dated 04.12.2015.

The same is against the interest of Government.

Circular No. DG/P&WA/55 OFFICE MEMORANDUM

Sub:--Inviting bids for comprehensive architectural and engineering services.

It has been observed that field units sometime invite offers from architects for comprehensive architectural and engineering consultancy jobs for various projects. Registration of the architects with the Council of Architect is sometimes kept as a prequalifying condition in some of the expression of interest (EOI)/ request for proposals (RFP)/ bid documents (NIT) for such consultancy jobs whereas pure engineering jobs have little or no role of Architects in such consultancy assignments. Appropriate Engineering experience is absolutely necessary to render such consultancy services.

EOI/RFP/NIT for comprehensive Architectural and Engineering consultancy jobs shall clearly lay down eligibility criteria compatible with components of the consultancy assignments. Any firm/ consultant (whether titled as an Architectural firm or an Engineering firm) or a joint venture thereof, which fulfils the laid down eligibility criteria in the EOI/RFP/NIT, shall be permitted to take part in the bidding process. Engineering firms shall be permitted to engage Architects registered with Council of Architect and with requisite experience to fulfil eligibility criteria and to take part in the bidding process. Likewise Architectural firms shall be permitted to engage Engineers of appropriate qualification and experience to fulfil eligibility criteria and to take part in the bidding process.
