## **PUBLIC NOTICE - NATA 2020**

Subject :- Revised Schedule for conduct of Second Test of NATA 2020 on September 12, 2020 – Clarification on Re-Test of candidates and other issues - reg.

Further to the Council's Public Notice dated 05.09.2020, the following clarification is issued to the candidates regarding conduct of NATA 2020:

- The Council shall conduct the Second Test of NATA 2020 in three sessions on September 12, 2020. The First and Third session shall be conducted as Centre Based Test (CBT) and the second session shall be a Home Based Test (HBT). The details of the same are specified in the Public Notice dated 05.09.2020 issued by the Council.
- 2. The pattern of questions, weightage of questions etc. of the Second Test shall remain same as mentioned in the NATA 2020 brochure.
- As already communicated to candidates, no fees will be charged from candidates who have been
  provided opportunity to appear for Re-Test of First Test of NATA 2020. The Re-Test shall also
  be conducted on September 12, 2020 and in case these candidates have registered themselves
  for Second Test, they shall be allotted different sessions on September 12, 2020.
- The HBT candidates (except overseas HBT candidates), who have been provided last opportunity for a Re-Test, shall be required to appear in CBT mode only, even for their Second Test, in case opted.
- The CBT candidates who are provided opportunity for a Re-Test and have recently changed their mode of examination for Second Test to "HBT", shall also be required to appear for Second Test as CBT only.
- 6. The candidates referred to at SI.No. 5 & 6 are not required to register for the Re-Test but only indicate Test city preferences in their login account on the NATA Portal as per the communication sent to them.
- 7. The candidates (including Re-Test candidates) shall soon be communicated about their respective allotted examination sessions and mode of examination through the admit cards being issued to them. No request for cancellation/rescheduling of Re-Test; change in mode of examination, session or test centre etc., received from any candidate, shall be entertained by the Council under any circumstances.
- 8. The Council shall conduct a Mock Test on September 8, 2020 for those HBT candidates who are registered for Second Test and have not given the same on earlier occasions.
